When you give it to us DIRECTLY

We obtain information about you when you:

- Attend our practice as a patient
- Complete documentation such as a Medical History form
- Agree to or request referral to other professionals
- Receive support from us by contacting us by telephone, text or email
- Take part in one of our surveys
- Attend one of our events
- Make payments to us using a card, credit agency or payment plan
- use our website or Social Media direct messages.

When you give it to us INDIRECTLY?

- We may receive information about you from a referring practice

When you give permission to OTHER ORGANISATIONS to share#

- If you permit other organisations to give us information such as if you apply for a loan in connection with treatment

What type of information

The type and quantity of information we collect and how we use it depends on why you are providing it.

Typically, the basic personal information we collect might include:

- **Your name**
- **Your contact details**
- **Your email address**
- **Your telephone number**
- **Your GP name and practice address**
- **Your next of kin or carer contact details**
- **Your family members names**

If you use our website we collect your IP address, and information regarding what pages are accessed and when.

How do we use your information?

- We process and use your information to provide you with safe dental care.

How long do we keep this information?

How do we keep this information safe?

- When you give us personal information, we take steps to ensure that there are appropriate technical measures in place to protect it. For example, access is restricted only to those who are entitled to see the data, our online templates and audits are always encrypted and our network is protected and routinely monitored.

Who has access to this information?

The Dental Experts Dentists, Nurses, Admin and Treatment Coordinators.

Your Rights

- You have a right to ask us to stop processing your personal data and, if it's not necessary for the purpose you provided it to us (e.g. to provide you with the services, products or information you asked for, processing your payment) we will do so.

We will only share this information with third parties for the following purposes:

- Third-party suppliers/partners: we may need to share your information with suppliers such as dental laboratories [**please check**] to help us deliver our services. They will only act under our instructions and are subject to contractual obligations containing strict data protection clauses.
- We will comply with requests where disclosure is required by law. We may also share your information with the emergency services if we reasonably think someone is in danger.
